
#### **Update on Transforming Care**

Anne-Marie and Sharon from the Transforming Care Team gave an update on this work. They reminded us that Transforming Care is a national government programme set up to run for 3 years. The team now employs 3 Experts by Experience.



Transforming Care is about improving services for people with learning disabilities and or autism, including those with mental health issues. Its main aims are for people to be able to live in the community with the right support and close to home. A large part of the team's work is attending Care and Treatment Reviews to make sure people are receiving the right services.

David asked about the recent

Sharon said she had seen examples of this in other hospitals. We know that large hospitals are not the right places for people to be.

measures are in place to stop things





Often people's physical health needs are overlooked. There was an example of this in the programme.

Here in Lincolnshire we have changed how services are delivered. LPFT has set up community hubs across the county. These have teams of different people e.g. social workers, specialist nurses, OTs and physios. They work alongside the Community Home Assessment Team (CHAT). They all make sure people have the right care at the right time, which stops people going into hospital. Hub map attached to minutes.

Sharon let the Board know that they will be holding a conference on 19<sup>th</sup> June for people to find out more about Transforming Care.







## Reasonable adjustment for people with learning disabilities

Mark Kowalski a nurse from LPFT learning disability community service talked about reasonable adjustments.

The law says that all health services must ask what extra things they need to do so people with disabilities can get health care like everyone else.

This might be

- Making sure information on health services is accessible
- Nurses with specialist skills to look out for people






- Giving people more time with doctors and nurse
- Making sure that annual health checks happen for everyone and that health problems are treated
- Involving family and carers in healthcare

These are called reasonable adjustments.

Mark explained that LPFT are working with all services to make sure changes are happening. He asked members of the Board how learning disability services could be made better. He will use this feedback to help improve services.

Jodi Weaver, Managing Advocate from TotalVoice gave an update on the advocacy service, they are working in partnership with Barnardo's, Lincs2Advice and Age UK Lincoln and Kesteven.

Within Lincolnshire, TotalVoice delivers free, independent and confidential advocacy which helps people speak up and get their views heard.
